The federal issues in need of immediate attention are:

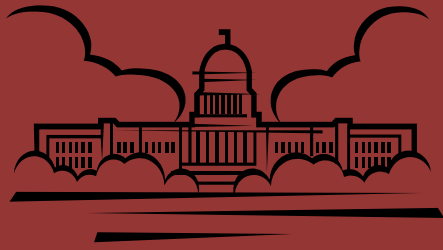
- Yield spread premium (YSP) which belongs to the consumer and is vital to a healthy, sustainable and competitive mortgage market place.

- The proposed Federal Reserve rules final implementation is fair and equitable to all mortgage distribution channels.
- The promise of a Consumer Financial Protection Agency (CFPA) that keeps the consumer's interests first and foremost through fair, equitable and transparent regulations of our industry.
- Permanently higher GSE loan limits.
